### Central Region Weekly Update July 31, 2020

I hope this update finds you safe and well. This week, Governor Pritzker announced revised guidelines for youth and adult sports. These new guidelines go into effect on August 15, 2020. The new guidelines have been posted on our website and can be found [here](#).

The state of Illinois is celebrating August's [National Black Business Month](#) by teaming up with Groupon to host a series of workshops for Black-owned businesses across the state. The Chicago-based company and the Illinois Department of Commerce and Economic Opportunity (DCEO) will host three virtual panel discussions for businesses and entrepreneurs during the month of August. Business workshops are FREE to attend and will bring together an all-star line-up of government officials, business industry groups, and Black business community leaders. That list includes: **Lt. Governor Juliana Stratton, Illinois Treasurer Michael Frerichs, Groupon's Interim CEO Aaron Cooper, DCEO Acting Director Michael Negron, Marc Morial, President, of the National Urban League, and local Small Business Administration (SBA) officials.** More information on these events and other events hosted by DCEO's Office of Minority Economic Empowerment (OMEE) is below.

### Restore Illinois

With the new 11 region format, the Central Economic Development region is now within two Restore Illinois regions. However, all regions are currently in Phase 4 of the Restore Illinois Plan. Please remain vigilant to keep us at this phase as we have seen the numbers start to rise across the state. Guidance documents and tool kits for Phase 4 can be found on our website [here](#). ### Program Updates:

- The **Downstate Small Business Stabilization Grant Program** is still accepting applications and funding is still available. DCEO has released the second round of grant awards for this program totaling \$1.94 million that will help an additional 93 businesses across the state. We are continuing to review applications that have been submitted and will be making additional announcements soon.
- **Local Coronavirus Urgent Remediation Emergency (Local CURE) Support Program:** Through this program, the State will take steps to deploy \$250 million to local governments in the coming months to help local governments secure reimbursement on eligible costs associated with the emergency response to the

ongoing COVID-19 crisis. DCEO has posted updated information on our website [here](#). The recording and presentation slides from the webinar that was held on July 29, 2020 are now on the website as well.

- **Child Care Restoration Grant Program:** The Governor and the Illinois General Assembly has directed at least \$270 million of the state's Coronavirus Urgent Remediation Emergency (CURE) Fund to support the economic health of child care providers as our economy reopens in the coming months. As part of CURE, the Business Interruption Grants (BIG) Program is specifically designed to support businesses who endure lost revenue due to the COVID-19 public health emergency. The Department of Commerce and Economic Opportunity in partnership with the Illinois Department of Human Services is charged to develop the grant program for licensed child care. The Child Care Restoration Grants will be administered by the Illinois Network of Child Care Resource & Referral Agencies (INCCRRA). **Applications are now being accepted under this program through August 14, 2020.** Information on this program can be found [here](#).

## **Coronavirus Response:**

### **DCEO Programs:**

#### **Downstate Small Business Stabilization Program**

**We continue to accept applications under this program.** This program will offer small businesses with at least one employee (not including the owner) and up to 50 employees the opportunity to partner with their local governments to obtain grants of up to \$25,000 for 60 days of working capital. Grant applicants should use the most current Guidebook for this program (4/14/20 version) as well as streamlined the GATA budget form for this program. Their contact information may be found [here](#). Applications that have been submitted are under review and we will continue to make announcements.

#### **Local Coronavirus Urgent Remediation Emergency (Local CURE) Support Program**

Through the Local Coronavirus Urgent Remediation Emergency (Local CURE) Support Program, the State will take steps to deploy \$250 million to local governments in the coming months. The additional state relief funds will help local governments secure reimbursement on eligible costs associated with the emergency response to the ongoing COVID-19 crisis. In the coming weeks, DCEO will administer funds from the Local CURE program to reimburse units

of local governments in counties across the state outside of Cook, Lake, Will, Kane, and DuPage Counties. These counties have received funding directly through the federal CARES Act. In rules filed with the Joint Committee on Administrative Rules, DCEO has developed a per capita and needs-based formula for allocating the Local CURE funding. More than eighty-five percent of the Local CURE Program's funding will be distributed to municipalities, county governments, and certified local public health departments. Remaining funds will be released by application to other units of local government. The application-based allotment will prioritize local governments serving disproportionately impacted areas, or DIAs, low-income zip codes that have had a significant number of cases of COVID 19 among residents.

Costs eligible for reimbursement are defined by the [US Treasury](#) and are those incurred due to the public health emergency response to the COVID-19 pandemic. These costs include public safety, public health, PPE materials, and more. Examples of eligible and ineligible costs are outlined on our website. To prepare for this program, you can do the following:

- Make sure your unit of local government is registered with SAM.gov.
- Review the program's administrative rules (soon to be posted under 14 Ill. Admin. Code § 700)
- Start collecting receipts for COVID-19 related expenses & digitize them; the department will seek PDFs and other electronic forms of back-up for reimbursements.
  - In addition, carefully consider descriptions and rationale on how expenditures were necessary in the local government's response to the COVID-19 public health emergency.
- Begin organizing year to date expenditures into the categories listed in the "eligible for reimbursement" section.

## **Small Business Administration (SBA) Programs**

### **Paycheck Protection Program**

The Paycheck Protection Program has reopened, and businesses can apply. The last day the SBA can accept applications from lenders is **August 8, 2020**. Information on this program may be found on the [SBA Website](#). Interested participants should work with their local lending institutions on pursuing this opportunity. SBA continue to issue guidance and FAQ's regarding this program.

### **Economic Injury Disaster Loan Program (EIDL)**

**All Illinois small businesses can again apply for the EIDL.** The SBA is offering low-interest federal disaster loans for working capital to small businesses and non-profit organizations that are suffering substantial economic injury as a result of COVID-19. While the EIDL Advance is no longer available, businesses can still apply for the EIDL loan.

- These loans may be used to pay debts, payroll, accounts payable and other bills that can't be paid because of the disaster's impact, and that are not already covered by a Paycheck Protection Program loan. The interest rate is 3.75% for small businesses and 2.75% for non-profits. The first payment is deferred for one year.
- EIDL applications that have already been submitted continue to be processed.

## Other DCEO Programs

### Office of Minority Economic Empowerment (OMEE)

The Office of Minority Economic Empowerment focuses and promotes opportunities for all minority communities across the state through targeted programs, resources and advocates. The goal is to ensure minority enterprises, including African American, Latinx, women, and veteran owned businesses, have an equal opportunity to contribute to the growth of the Illinois economy and serve as an advocate for businesses, entrepreneurs and start-ups in traditionally economically-disadvantaged groups.

OMEE will host a series of webinars to celebrate **National Black Business Month** beginning August 1<sup>st</sup>, 2020. We have partnered with **Groupon** and many other organizations and businesses to facilitate panels discussions to address issues facing Black Owned businesses in Illinois. ## Get Hired Illinois

DCEO in conjunction with IDES launched the Get Hired Illinois. This is a new portal designed to connect workers with available job and career training opportunities across the state. Governor Pritzker also announced that beginning in June, Illinois residents will have free access to online workforce development courses via a partnership with Coursera. This portal blends IDES and DCEO resources to provide a one-stop-shop for both job seekers and employers – providing information on job opportunities as well as unemployment resources. The portal is designed to be user-friendly for job seekers of all levels and backgrounds and allows employers to upload jobs, virtual career fairs and training opportunities. ## Rebuild Illinois Opportunities

**Fast Track Public Infrastructure:** Applications submitted under this program are currently under review.

**Regional Economic Development:** Local governments, economic development organizations, non-profit organizations, and private companies will be eligible to apply for grants of up to \$2 million on a rolling basis. Funds can be used to support a range of activities including architectural planning and engineering design, land and building acquisition, demolition, costs related to site selection and preparation, utility work, and new construction, among other uses. Applicants will be asked to frame how their proposed projects align with any regional economic plans as well as the [Governor's Five-Year Economic Plan](#). Successful applicants will be able to demonstrate strong regional support for their projects and lay out a clear vision for job creation by the proposed investment. DCEO will accept applications for regional economic development on a rolling basis. For additional

**Shovel-Ready Sites:** Local governments, economic development organizations, non-profit organizations, and private companies will be eligible to apply for grants of up to \$2 million for most projects and \$1 million for brownfield rehabilitation on a rolling basis. These funds will support investment in sites with great economic development potential that require additional investment in order to become shovel-ready, which includes costs such as site acquisition, environmental site assessment, architectural planning and engineering design, demolition, utility work, and other construction work related to site preparation and improvement. DCEO will seek strong grounding of proposed projects in the [Governor's Five-Year Economic Plan](#) along with any regional economic plans or site-specific plans available. DCEO will accept applications for shovel ready sites on a rolling basis. For additional information on these funds, prospective applicants can visit DCEO's website [here](#). ## **Economic Development Administration**

**Economic Adjustment Assistance Program (EAA):** The EAA program provides a wide range of technical, planning, and public works and infrastructure assistance in regions experiencing adverse economic changes that may occur suddenly or over time. The EAA can assist state and local entities through strategy grants and implementation grants. The CARES Act made \$225 million available through the EDA Chicago Regional Office, which includes Illinois, Indiana, Michigan, Minnesota, Ohio and Wisconsin. Applications under this program became available on May 7<sup>th</sup> and will be accepted on a rolling basis until funds run out. The minimum project amount is \$100,000.

### **USDA Outreach and Assistance for Socially Disadvantaged Farmers and Ranchers and Veteran Farmers and Ranchers Funding Opportunity**

The overall goal of this program is to encourage and assist socially disadvantaged farmers and ranchers, veteran farmers and ranchers, and beginning farmers and ranchers with owning and operating farms and ranches and in participating equitably in the full range of agricultural, forestry, and related programs offered by USDA. In partnership with the OPPE, eligible entities may compete for funding on projects that provide education and

training in agriculture, agribusiness, forestry, agriculturally related services, and USDA programs and to conduct outreach initiatives designed to accomplish those goals. See the link below for additional information. Eligible applicants include:

- Private institutions of higher education
- Public and State controlled institutions of higher education
- Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education
- Native American tribal governments (Federally recognized)
- Native American tribal organizations (other than Federally recognized tribal governments)
- Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education

If businesses have personal protection equipment (PPE) that they would like to **donate**, they can send an email to the State of Illinois' Covid-19 Donation Intake Team ([ppe.donations@illinois.gov](mailto:ppe.donations@illinois.gov)). Please note that all items should be in the manufacturer's original packaging and unopened, as they cannot accept open products or homemade items. For non-PPE related donations, businesses may reach out to [businessdonations@illinois.gov](mailto:businessdonations@illinois.gov).

If businesses have PPE that they are interested in **selling** to the state, they can send an email to the State of Illinois' Covid-19 PPE Procurement Team ([covid.procurement@illinois.gov](mailto:covid.procurement@illinois.gov)). In the email, they should indicate the following:

- What PPE is for sale
- The quantity of these items
- The price of these items
- The location of these items

If businesses have a facility and are capable of **manufacturing PPE** or are able to quickly make the switch to manufacture PPE, they should reach out to the Illinois Manufacturing Excellence Center [here](#).
